**MINUTES
 PARKS, RECREATION, AND CLEAN CITY COMMISSION
 September 8, 2025**

The Parks, Recreation, and Clean City Commission met on the above date at 5:00 p.m. with Chairwoman Pearl Jones presiding. The following Commissioners and Officials were present: Darryl Givens, Rayford Johnson, Quincy Wallace, Brian King, City Manager Venus Wehle, Public Works Director Robert Duenes, and City Secretary Amy Anderson.

Commission Darryl Givens arrived at 5:14 p.m.

1. Call to Order

With a quorum present, Vice Chairman Johnson called the meeting to order at 5:07 p.m.

Invocation – Commissioner Johnson led the invocation.

Pledge of Allegiance to the U.S. Flag and the Texas Flag – led by Vice Chairman Johnson

2. Citizens Testimony: At this time, any person who desires to speak on any item posted on the agenda or any person with business before the Parks, Recreation, and Clean City Commission not scheduled on the agenda may speak to the Commission, provided that a “Speaker’s Request Form” has been completed and provided to the City Secretary prior to the start of the Commission meeting. Speakers are limited to a maximum of three (3) minutes. The Commission cannot respond to matters not listed on the agenda until scheduled at a future meeting. Please direct all comments to the Chairperson of the Commission. Citizens are to refrain from personal attacks.

3. Consent Agenda:

4. Deliberation Agenda:

a) Discussion on Yard of the Month 2025

Commissioner Johnson provided an update on the Yard of the Month 2025 program.

Chairwoman Jones addressed the Commission on their submittals. They need to be on time

Amy Anderson, City Secretary, stated that the submittals come from the same area of the City, and some addresses have been submitted multiple times.

Commissioner Johnson stated that in some areas, it is challenging to find quality homes to submit.

Commissioner Wallace stated that as long as the addresses have not won, they can be submitted multiple times.

Commissioner Johnson further stated that he needs to know what is being submitted to keep track of the addresses. Chairwoman Jones stated that each Commissioner needs to keep track of their own submittals.

b) Discussion on the Fall 2025 Citywide Cleanup event.

The event will be held on Saturday, November 8, 2025, in the Fitness Connection parking lot from 8:00 a.m. to 1:00 p.m. It is for residents only, and proof of residency will need to be provided.

The Commission discussed different vendors that could assist with the cleanup, such as shredding, recycling, and Goodwill.

Safety items were discussed and will be provided. The Commissioners are to wear their red shirts.

Volunteers will be needed for the event.


Chairwoman Jones adjourned the meeting at 5:47 p.m.
